Use of Related Forms: Within 30 days of hiring a New Instructor, complete Forms 1140CM 1145CM, and 1155CM including obtaining required signatures and a Notary of the Form 1155CM. For an existing Instructor, already approved by the OBPVS, only the Form 1155CM is required as part of annual Relicensing. A mid-year submission only to add a Course(s) to an existing (already-approved) Instructor’s assignments **requires ONLY the Form 1145CM.**

Instructions: This form must be signed to signify approval of the Authorized Administrative Official or Director(already approved by the OBPVS), or the Dean of Academics.

Certification: I certify that all current Instructors are listed, and that each of the Instructors listed meet the Board’s minimum requirement in OAC 565:10-11-1(d). I further certify that the courses previously listed include all courses currently taught. **If not, attach a Form 1145CM with the Re-Licensing Application to revise the OBPVS’ Record for an Instructor(s) for whom the OBPVS listing of assignments is out-of-date.** I understand that any future changes, including new or terminated Instructors or changes in course assignments must be filed with the OBPVS office **for approval** within 30 days of the change.
